Message from Charlie Hickox, President

While 2020 started out on a high with the joyous celebration of our 20th anniversary and the ceremonial burning of the mortgage, the dark clouds of the pandemic soon

appeared on the horizon. During March and April RVCC effectively shut down as classes, meetings and get-togethers were cancelled, the Treasure Chest and Taj Mahal shuttered and we worried about paying wages, bills and keeping the lights on.

Gradually over the late spring and summer RVCC recovered, thanks in part to efforts of our membership, governmental loans and generous donors' financial support. The Treasure Chest re -opened safely, the auditorium became a location for food deliveries, meetings continued via Zoom, Trager Brothers kept selling coffee and our annual membership drive exceeded expectations. Work building the outdoor stage continued while planning and grant solicitation continued on relocating and expanding the skate park.

2020—The Year in Review

A Few Highlights...

- A terrific 20th Anniversary Party on "leap night," celebrating the dawn of our third decade and our outright ownership of 190 Rockfish School Lane with the burning of the mortgage;
- Receipt of two "challenge grants" from the High Point Fund, to provide initial funding of the replacement/relocation of the SK8 ramp and the expansion of our solar power generation capacity;
- Receipt of a very generous outright grant from the Sahm Family Foundation for the SK8 project, providing more than enough funding to match the High Point Fund challenge grant and moving the project to the top of the list for completion in 2021;
- Welcoming Lisa Davis, our new part-time Community Engagement and Event Coordinator in the Fall, helping us to manage fundraising events and rentals, and to reach out to untapped sources of membership and facility usage;
- Receipt of a repayable grant through the EIDL program of the Small Business Administration in April, to help fund operations during the pandemic, and the subsequent forgiveness of the repayment requirement in December;
- A herculean effort by Treasure Chest staff and volunteers to re-tool procedures and protocols to get re-opened safely at the beginning of summer, and to post some of the best revenue numbers in our history;
- Receipt of a SBA Paycheck Protection Program loan through UVA Community Credit Union to cover payroll expenses in the early months of the pandemic, and the expected forgiveness of the loan this year, prior to its maturity;
- Permission from the Community Foundation/Central Blue Ridge and the Schaeneman Foundation for the conversion of restricted funds approved for our Men's Room and Studio Upgrades project to unrestricted use during the pandemic;
- An outstanding fundraising effort by our SK8 Nelson Committee, raising more than \$5,000 in donations and merchandise sales to offset our liability insurance premium, despite having to cancel the SK8 Nelson Festival during the summer;
- An unprecedented outpouring of support from our membership to launch the "Recovery 2021" Annual Fund and Membership Campaign, lifting lagging 2020 revenues enough during November and December to break even in an otherwise dismal year; but most importantly
- Our survival of one of the most challenging years in our lifetimes, keeping our doors open and continuing to be the place "where community happens" for you and your neighbors in Nelson County!



Programs and Fundraising

While not quite the year of celebration we had hoped for, 2020 has led us to find new ways to connect with our neighbors, and a new understanding of what community truly means.

20th Anniversary Party



On February 29, 2020, we celebrated RVCC's 20th Anniversary in true community center style: with a community potluck, great music, excellent libations, and of course we had to set something on fire! We had not only made it to the 20-year mark, but we had also just paid off our mortgage, so we cheered our survival and our freedom with an old-fashioned mortgage-burning as well. Our first party of the year turned out to be our last party of the year, as the pandemic drove everyone to stay home and stay safe.

Fresh Food Weekly Pickup



In late March, RVCC launched a "fresh local food" program as a way to address two pandemic-created problems in our community: the high risk of public areas, and the absence of market opportunities for our local farmers at a crucial time in their production schedule. Our weekly food pickup allows our community to order meat, vegetables, fruit, dairy, baked goods and more from our local farmers, and pick up their orders in a safe environment each week. Over the course of the past year the program has included River Oak Farm, Double H Farm, Hindes Harmony

Farm, Old Orchard Farm, Little Hat Creek Farm, Caromont Farm, Goodwin Creek Bakery, Gathered Threads, Verdant Acres, Virginia Vinegar Works, and 4P Foods.

The Treasure Chest Thrift Store



The Treasure Chest thrift store has been a source of financial support for RVCC since its opening in 2001. The store performs an essential service for the community: this is a place where people can recycle and find all types of gently used items. In addition to serving shoppers, store staff and volunteers often serve a more quiet service. On a daily basis, people's needs are met whether or not they are able to pay. When items cannot be sold, most of what is culled from the inven-

tory goes to another organization that serves the low-income population of Nelson and elsewhere. The Treasure Chest had to close down for a few months in 2020, but is now back to full operations.

SK8 Nelson



In 2009, Nelson County's first and only skate park opened at RVCC. The SK8 Nelson skate park has always been free and open to the public, but it costs RVCC upwards of \$4000/year in liability insurance premiums and maintenance expenses. In the ab-

sence of the annual SK8 Nelson Fundraising Festival in 2020, the SK8 Nelson Committee accomplished what initially seemed like an impossible task: they

met and exceeded that fundraising goal through merch sales and individual donations!



RVCC Gains Two New Team Members




